WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 72. Food production

Specifically failed to comply with the following:

s. 72. (2) The food production system must, at a minimum, provide for, (d) preparation of all menu items according to the planned menu; O. Reg. 79/10, s. 72 (2).

Findings/Faits saillants :

1. The licensee failed to ensure that the food production system included the preparation of all menu items according to the planned menu.

During the noon meal on March 27, 2015, desserts on the planned menu included fruited jello with whipped topping, or coconut pudding, for the regular diets and diet fruited jello with whipped topping, or diet vanilla pudding, for the modified diabetic diets. Residents on modified diabetic diets were not offered the modified diabetic dessert options during the meal service and were served regular dessert items. There were no diabetic desserts available, in the dining room, as confirmed by the PSW. Interview with the FSM confirmed that the home did not prepare the modified diabetic dessert menu items for the identified meal, as per the planned menu. [s. 72. (2) (d)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensure that the food production system includes the preparation of all menu items according to the planned menu, to be implemented voluntarily.
