WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 231. Resident records Every licensee of a long-term care home shall ensure that,

- (a) a written record is created and maintained for each resident of the home; and
- (b) the resident's written record is kept up to date at all times. O. Reg. 79/10, s. 231.

Findings/Faits saillants:

1. The licensee did not ensure that the written record was kept up to date for the identified resident.

The identified resident passed away at the home. The documentation in the progress notes on the resident's health record during the evening prior to the resident's death indicated that the resident was unresponsive and was unable to take anything by mouth including pills. The resident was noted to have received narcotic medication for comfort. The identified resident's family requested to be notified if the resident's condition changed. It was noted in the same progress note that the staff would continue to monitor.

There was no documentation in the identified resident's health file related to their condition or any monitoring activities that took place during the next shift.

The next progress note was noted to be the following morning and this progress note indicated that the physician was called and information was provided. It was noted that the physician would notify the coroner if necessary. The next note the same day indicated that the physician called to say that they had spoken with the coroner and that the coroner would be in to review the resident's chart.

There was no documentation on the identified resident's health file to indicate the time of the resident's death, whether family were notified of their death and when, when the resident's body was released to the funeral home, when the coroner visited the home to review the chart or the cause of death as determined by the coroner.
