Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

Specifically failed to comply with the following:

s. 30. (2) The licensee shall ensure that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions are documented. O. Reg. 79/10, s. 30 (2).

Findings/Faits saillants :

1. The licensee failed to ensure that any actions taken with respect to a resident under a program, including assessments, interventions and the resident's responses to interventions were documented.

A review of the clinical record for resident #021 including the progress notes and food/fluid intake sheets for three months indicated the resident was on a diabetic diet, minced texture with nectar thickened fluids and had an order for Resource Liquid 125 ml at morning and afternoon snack. The food and fluid intake sheets did not indicate that the resident received this supplement for October, November, December except on 2 dates in October and one in December 2011. The ADOC confirmed the documentation omissions. [s. 30. (2)]
