The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator and the Director of Care.

During the course of the inspection, the inspector(s) reviewed the health record of a deceased resident.

One Written Notification was issued as a result of this inspection.

WN #1: The Licensee has failed to comply with The Long-Term Care Homes Program Manual Standards and Criteria

Criteria B2.13 Unmet criterion which stated:

Each resident who is assessed as being at risk for altered skin integrity, or whose skin integrity has been compromised, shall have that risk or condition documented in the residents plan of care. The plan of care shall outline the skin care measures to be provided to the resident. These measures shall include but not limited to :

- promotion of healing
- optimizing nutrient intake
- minimizing pain and discomfort
- efforts to prevent deterioration and infection

This criteria is unmet as evidenced by:

Review of the health record for an identified deceased resident indicated the resident had alteration in skin integrity and did not have a plan of care related to alteration in skin breakdown.
