The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 11-15, 19-22, 25-28 and March 1, 2019.

A Critical Incident Inspection #2019_668543_0004 and a Complaint Inspection #2019_668543_0006 were conducted concurrent with this inspection.

One intake related to compliance order #001, from inspection report #2018_669642_0019, regarding O. Reg., section 6 (7) was inspected.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), Nurse Managers, Physicians, Behavioural Support Service (BSS) Staff, Registered Nurses (RN), Registered Practical Nurses (RPN) and Personal Support Workers (PSW).

The Inspectors also observed resident care areas, the provision of care and services to residents, staff to resident interactions, reviewed relevant health care records, internal investigation documents and policies and procedures.
