The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 31. Nursing and personal support services

Specifically failed to comply with the following:

s. 31. (4) The licensee shall keep a written record relating to each evaluation under clause (3) (e) that includes the date of the evaluation, the names of the persons who participated in the evaluation, a summary of the changes made and the date that those changes were implemented. O. Reg. 79/10, s. 31 (4).

Findings/Faits saillants :

1. The licensee did not ensure a written record of the annual evaluation of the staffing plan for 2012 was completed that included the date of the evaluation, a summary of the changes made and the date that those changes were implemented.
When interviewed the Acting Director of Care confirmed a written record of the annual evaluation of the 2012 staffing plan had not been completed. [s. 31. (4)]
