The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 8-10, 2017.

This Follow Up inspection was related to three compliance orders (COs) issued during inspection #2017-572627-0014. Specifically:

CO #001 which was related to O.Reg 79/10, s. 51. (2), staff not providing continence care as required to residents;

CO #002 which was related to O.Reg 79/10, s. 135. (2), corrective actions not taken in light of medication incidents; and

CO #003 which was related to O.Reg 79/10, s. 41, rest routines not supported.

A Critical Incident inspection #2017-638609-0022 was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), Nurse Practitioner (NP), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.

The inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident and resident to resident interactions, reviewed relevant health care records and reviewed numerous licensee policies, procedures and programs.
