One log, related to compliance order (CO) #001 that was issued during inspection #2019-671684-0015, r. 90 (2)(i) of the Ontario Regulation 79/10, specific to ensuring the temperature of hot water serving all bathtubs and showers used by residents were maintained at a temperature of at least 40 degrees Celsius.

The Inspector also conducted tours of the resident care areas, observed the provision of care and services to residents, reviewed relevant audits and resident health care records.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Environmental Supervisor, Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.
