The purpose of this inspection was to conduct a Follow up inspection.

During the inspection the following follow up orders were inspected:

#022519-18 - regarding continence care and bowel management and medication administration,

#022520-18 - regarding neglect,

#023443-18 - regarding resident to resident abuse and responsive behaviour,

#030682-18 - regarding responsive behaviour,

#027173-18 - regarding neglect of a resident with changed condition.

During the course of the inspection, the inspector(s) spoke with Director of Care (DOC), Nurse Manager (NM), Staff Development coordinator, Quality improvement lead and Clinical Information Back up, Behavioural Support of Ontario (BSO) Lead, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Environmental Manager, and Residents.

During the course of the inspection, the inspector observed staff and residents interactions, staff managing residents with responsive behaviour, provision of care including toileting, observed main dining room and second floor for air temperature, reviewed home action plan and follow up orders, clinical health records and relevant policy and procedures.
