1. The Licensee has failed to ensure, if the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval; and (d) contact information for the Director. 2007, c. 8, s. 44. (9).

On an identified date, the Director received a complaint in regards to the withholding approval for admission for applicant #001.

Record review of the written notice from the home to applicant #001 on an identified date, indicated after carefully reviewing the application and a visit, the home was unable to provide appropriate accommodation the applicant required. The written notice further stated the home was rejecting the application as "nursing home lacks physical facilities necessary to meet applicant's needs" and specifically the home could not accommodate the applicant's behaviours and life style at the time.

The written notice did not provide a detailed explanation of the appropriate accommodation and how the home lacks the physical facilities to meet the applicant's needs. There was no supporting evidence that the legislative requirements under b, c and d were demonstrated in the written notice.

In an interview, the Administrator confirmed that the written notice sent to applicant #001 on the identified date, did not provide the applicant, the Director and the appropriate placement coordinator:

-a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care,

-an explanation of how the supporting facts justify the decision to withhold approval, and -contact information for the Director. [s. 44. (9)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure, if the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval; and (d) contact information for the Director, to be implemented voluntarily.
