WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants:

1. Not all residents are protected from abuse by anyone and free from neglect by the licensee or staff in the home. An identified resident was not protected from abuse. In 2011 an identified resident was struck on the head by another resident, which resulted in a hematoma and small abrasion to the head. Documentation and staff interviews indicate the aggressor had known responsive behaviours and prior episodes of aggression towards others.
