WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

s. 6. (8) The licensee shall ensure that the staff and others who provide direct care to a resident are kept aware of the contents of the resident's plan of care and have convenient and immediate access to it. 2007, c. 8, s. 6 (8).

Findings/Faits saillants:

- 1. Staff interview with Director of Care confirmed she is aware of a soft ware problem in the home and that the home has not been able to update a certain Resident's care plan if there was a need, for 54 days.
- 2. Staff interview with RAI Co-ordinator revealed the home's software "Mede-Care," has not been able to update information related to a certain resident for 54 days. The care plan showing on the computer has not been updated nor is the home able to print a Kardex with any changes over the last 54 days. The RAI Co-ordinator also stated "the home does not print hard copies of the care plan" any more. The Registered staff were instructed to write any changes in the Progress notes.
- 3. Staff interview with a Registered Nurse and a Registered Practical Nurse, revealed that they are unaware of this situation and did not know that they were to write any changes in the progress notes that would be entered into the care plan when the problem was corrected.
