1. The Licensee failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan when the following occurred:

A.)

Resident #02's plan of care for recreational activities includes a number of interventions.

Record review with Recreation Assistant confirmed that resident #02 had been provided only one of the activities, from April 1, 2014, to May 27, 2014.

During an interview the Life Enrichment Program Manager confirmed her expectation that residents be provided recreational activities as per their plan of care.

B.)

Resident #02's plan of care indicates that the resident is to be provided a textured modified diet with a specific portion size.

Observation of the lunch meal, May 28, 2014, revealed that the resident was not provided the correct textured diet or portion size.

The Food Services Manager indicated that the correct diet texture is on the resident's diet kardex and staff should be following the kardex to ensure that each resident is provided with the care set out in their nutritional plan of care. [s. 6. (7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that the care set out in the plan of care is provided to the resident as specified in the plan related to recreational activities and nutritional diets, to be implemented voluntarily.
