The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 30th and 31st, 2017

This complaint inspection was related to a complaint regarding the South bathtub and shower, and bathing of residents.

During the course of the inspection, the inspector(s) spoke with The Administrator, the former acting Administrator, the Director of Care, the Environmental Services Manager from another Extendicare Assist managed home who provides occasional maintenance service to Manoir Marochel, the Activity Director, a housekeeper, registered and non registered nursing staff, and residents.

During the course of the inspection, the Inspector observed the South bathtub and shower rooms. The Inspector observed nursing staff demonstrate the process currently required to bring residents into the South shower stall when in the shower chair. The Inspector measured water temperatures in the South shower.
