Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 27 and 28, 2022.

The following intakes were completed in the Critical Incident System Inspection: Log #019545-21 (CIS# M554-000013-21) and Log #019890-21 (CIS# M554-000015-21) related to Incident that caused an injury to a resident for which the resident was taken to hospital and which resulted in a significant change in the resident's health status.

During the course of the inspection, the inspector(s) spoke with Personal Support Workers (PSWs), Program and Support staff member, Housekeeper, Registered Practical Nurse (RPN), Registered Nurse (RN), Director of Care and the Administrator.

During the course of the inspection, the inspector observed infection control practices, residents rooms, resident home areas, and interactions between staff and residents. A review of relevant records was also completed including a review of a resident's health care record.
