The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 6, 7 and 10, 2014

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Assistant Director of Care (ADOC), several Registered Nurses, several Registered Practical Nurses, a Personal Support Worker , a Housekeeper and two residents.

During the course of the inspection, the inspector(s) reviewed the health records for Resident #1 and #2, the handout titled "Every Resident, Bill of Rights for people who live in Ontario long-term care homes" dated December 2011, observed care being provided to residents, interactions between residents and between staff and residents.
