Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The Licensee has failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Review of the resident's care plan revealed multiple interventions to be used as the resident may have unpredictable behaviour.

Chart review did not reveal documentation that any of the above interventions were trialed and found to be ineffective.

Chart review revealed documentation in the progress notes whereby care was to be given " against the resident's wishes " and "at the same time restricting arms" to provide care.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.
