NC #001 Written Notification pursuant to FLTCA, 2021, s. 154 (1) 1.

Non-compliance with: O. Reg. 246/22, s. 53 (1) 1.

Required programs

s. 53 (1) Every licensee of a long-term care home shall ensure that the following interdisciplinary programs are developed and implemented in the home:

1. A falls prevention and management program to reduce the incidence of falls and the risk of injury.

The licensee has failed to ensure that a head injury routine (HIR) was completed after every fall as directed by the licensee's falls program policy.

In accordance with O. Reg 246/22 s. 11 (1) (b), the licensee is required to have a falls prevention and management program to reduce the incidence of resident falls and the risk of injury and it must be complied with.

Specifically, staff did not comply with the licensee's Interdisciplinary Falls Prevention and Management Program policy, revised October 2023, which includes the Head Injury Assessment policy, following an unwitnessed fall of a resident in May 2024.
