1. The inspector reviewed the health care record for three residents (#218, #350, #450). Each resident's plan of care outlines that they are to be repositioned every 2 hours when in bed. Over the course of the inspection, the inspector interviewed nursing staff including a registered nurse, personal support worker and registered practical nurse, who reported if a resident's plan of care outlines they are to be repositioned every 2 hours when in bed, staff do not document the resident has been repositioned as set out in their plan of care. The licensee has not ensured that the following is documented: The provision of the care set out in the plan of care. [s. 6. (9)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff document the provision of care set out in the plan of care, specifically related to residents #218, #350 and #450, and any other resident who requires repositioning every 2 hours when in bed, as outlined in their plan of care, to be implemented voluntarily.***
