WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 78. Food service workers, training and qualificationsTraining and qualifications

Specifically failed to comply with the following:

s. 78. (2) The licensee shall cease to employ as a food service worker a person who was required to be enrolled in a program described in subsection (1) if, (a) in the case of a program referred to in clause (1) (a), the person ceases to be

enrolled in the program or fails to successfully complete the program within three years of being hired; or

- (b) in the case of a program referred to in clause (1) (c), the registration of the person's training agreement is cancelled, suspended or revoked, or the person fails to receive his or her statement of successful completion of a program under the Apprenticeship and Certification Act, 1998, or certificate of successful completion of a program under the Ontario College of Trades and Apprenticeship Act, 2009, as the case may be,
- (i) within three years of being hired, in the case of an apprenticeship program in the trade of Assistant Cook, or
- (ii) within five years of being hired, in the case of an apprenticeship program in the trade of Cook or Institutional Cook.

Findings/Faits saillants:

1. The licensee has failed to ensure that a Food Service Worker, who fails to successfully complete the Food Service Worker training program within three years of being hired, cease to be employed.

On an identified date, the Ministry of Health and Long-Term Care received an anonymous complaint. As result, staff personal files were reviewed.

Review of staff #110's personal file revealed he/she was hired as a Dietary Aide in the home in an identified year, with proof of enrollment in Food Service Worker Program at Centennial College on the same year, the expectation was to successfully complete the program within three years. On a specified date, the Food Service Supervisor had sent a letter to remind staff #110 to complete the Food Service Worker Certificate by the end of the specified year, which is third years after the date of hire.

Further review of staff #110's personal file failed to reveal an ongoing enrollment in the Food Service Worker Certificate program or proof of completion of the above mentioned program.

Review of the Dietary Department Schedule for a specified period of time, revealed that staff #110 had been scheduled for ten shifts.

The inspector was not able to interview the staff as he/she was not available during the inspection.

Interview with Food Service Supervisor and DOC confirmed that staff #110 had not completed the required Food Service Worker Certificate at the time of the inspection, as the home extended the period outlined in the Long-Term Care Home Act. [s. 78. (2) (a)]
