The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): January 23, 2013

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Care, Co-Director of Care, Food Services Supervisor, Environmental Services Supervisor, Life Enrichment Coordinator, RAI Coordinator, Office Manager, Resident and Family Services Coordinator, two Registered Nurses, four Registered Practical Nurses, 7 Health Care Aides/Personal Support Workers, one Housekeeper, four Family Members and three Corporate Care Services Coordinators.

During the course of the inspection, the inspector(s) monitored air temperatures throughout the home (including resident bedrooms, hallways and all common areas), observed lunch meal in both dining rooms, morning snack service, medication administration throughout the home, availability of vaccines and reviewed immunization records of residents and staff.
