WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8. Nursing and personal support services

Specifically failed to comply with the following:

s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

#### Findings/Faits saillants:

1. The licensee failed to ensure that at least one registered nurse (RN) who was an employee of the licensee and a member of the regular nursing staff was on duty and present at all times unless there was an allowable exception to this requirement (see definition/description for list of exceptions as stated in section 45. (1) and 45.1 of the Regulation).

The Meadows of Dorchester has a licensed capacity of 121 beds and did not qualify for any exceptions as specified in the regulations. During this complaint inspection, log #018569-19, it was identified that the home did not have an RN in the building for four identified days.

A review of the RN schedules identified that an RN worked onsite on one identified day in the complaint. Further review of the RN schedules identified that the home utilized a contracted agency RN to cover three vacant shifts.

This information was reviewed by the Director of Resident Care, who confirmed that the need to fill the RN shift was not a result of an emergency situation as outlined in O. Reg 79/10, s. 45(2) and that the contracted agency RN was not an employee of the licensee or a member of the regular nursing staff of the home. [s. 8. (3)] [s. 8. (3)]

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance at least one registered nurse (RN), who is an employee of the licensee and a member of the regular nursing staff is on duty and present at all times unless there is an allowable exception to this requirement (see efinition/description for list of exceptions as stated in section 45. (1) and 45. 1 of the Regulation), to be implemented voluntarily.
