The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): July 21, 2015

Two separate complaints were investigated, one related to the sanitation level of the main floor visitor/resident washroom and the second related to the maintenance of the heating and cooling units located in resident bedrooms and methods employed to control for cold air drafts during winter months.

During the course of the inspection, the inspector(s) spoke with the Administrator, maintenance person and several family members regarding air temperatures, reviewed maintenance related documentation and maintenance processes with respect to on going inspections and repairs of the heating and cooling units located in resident rooms and dining rooms and a general tour of the building including resident rooms, resident washrooms, visitor washroom and common areas for general sanitation.
