A follow up inspection (2017-539120-0019) was previously conducted on March 16, 2017, for non-compliance related to the home's emergency plans related to the procurement of a generator and managing services when hydro is not available such as heat, emergency and safety equipment, the resident-staff communication and response system and elevator service. Two orders were issued on April 19, 2017. For this follow-up inspection, the specified emergency plans were reviewed and determined to meet the conditions laid out in the two orders.

An onsite visit to the home was not necessary. Communication with the Administrator was conducted via telephone and email. All required documentation required in orders #001 and #002 was provided by email for review.
