The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): March 10, 2017

An inspection (2015-275536-0006) was previously conducted March 12-20, 2015 and non-compliance identified related to insufficient lighting levels throughout the home. An order was issued as a result. During a subsequent inspection (2016-210169-0014) conducted September 22-29, 2016, sufficient lighting levels were not met in resident rooms and common spaces and an order issued. For this follow-up visit, the lighting levels were determined to be compliant and the order closed.

During the course of the inspection, the inspector(s) spoke with the Assistant to the Administrator.

During the course of the inspection, the inspector toured both the 1st and 2nd floors and took illumination levels with a hand held portable digital light meter in random resident rooms and in the lounge space on each floor.
