**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care**

**Specifically failed to comply with the following:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that the care set out in the plan of care was provided to two residents as it related to the application of a device.

A resident was at risk for falls, and one of the interventions in their care plan was for staff to apply a device when they were seated in a chair. On one occasion, the resident had an unwitnessed fall in a non-residential area. Prior to the unwitnessed fall, staff had last seen the resident seated in the common area, and the device was not in place at that time.

By not ensuring the application of the device, staff were not able to respond as quickly to prevent the fall. The resident's fall resulted in a significant change in their health condition.

**WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 9. Doors in a home**

Specifically failed to comply with the following:

**s. 9. (1) Every licensee of a long-term care home shall ensure that the following rules are complied with:**

**2. All doors leading to non-residential areas must be equipped with locks to restrict unsupervised access to those areas by residents, and those doors must be kept closed and locked when they are not being supervised by staff. O. Reg. 79/10, s. 9; O. Reg. 363/11, s. 1 (1, 2).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that the door leading to a non-residential area was locked when they were not being supervised by staff.

On one occasion, a resident had an unwitnessed fall in a non-residential area, which resulted in a significant change in their health condition. A staff member did not lock the door and the resident opened the door and entered the non-residential area. The Falls Lead RN stated that the door leading to the non-residential area must be locked at all times when not being supervised by staff.

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the following rules are complied with: All doors leading to non-residential areas must be equipped with locks to restrict unsupervised access to those areas by residents, and those doors must be kept closed and locked when they are not being supervised by staff, to be implemented voluntarily.***

3. Assign individual(s) who will conduct the audits as soon as each shift begins and before each shift ends.
4. A record is required to be kept by the licensee for all actions undertaken in items #1 and #3. The record shall be made available to the inspector upon request.

**Grounds / Motifs :**

1. The licensee failed to ensure that the care set out in the plan of care was provided to two residents as it related to the application of a device.

A resident was at risk for falls, and one of the interventions in their care plan was for staff to apply a device when they were seated in a chair. On one occasion, the resident had an unwitnessed fall in a non-residential area. Prior to the unwitnessed fall, staff had last seen the resident seated in the common area, and the device was not in place at that time.

An order was made by taking the following factors into account:

**Severity:** There was actual harm to a resident as the fall incident resulted in a significant change in their health condition. There was minimal risk of harm to another resident when their device was not implemented, as the registered staff applied the device after the inspector and the Falls Lead RN identified that it was not in place.

**Scope:** Out of the three residents reviewed, two residents did not have the required device in place, demonstrating a pattern of non-compliance.

**Compliance History:** In the last 36 months, the licensee was found to be noncompliant with s. 6 (7) of the LTCHA, and 2 Written Notifications (WNs) and 2 Voluntary Plan of Corrections (VPCs) were issued to the home. (653)

If the Licensee is not served with written notice of the Director's decision within 28 days of receipt of the Licensee's request for review, this(these) Order(s) is(are) deemed to be confirmed by the Director and the Licensee is deemed to have been served with a copy of that decision on the expiry of the 28 day period.

The Licensee has the right to appeal the Director's decision on a request for review of an Inspector's Order(s) to the Health Services Appeal and Review Board (HSARB) in accordance with section 164 of the Long-Term Care Homes Act, 2007. The HSARB is an independent tribunal not connected with the Ministry. They are established by legislation to review matters concerning health care services. If the Licensee decides to request a hearing, the Licensee must, within 28 days of being served with the notice of the Director's decision, give a written notice of appeal to both:
