The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

**WN #1:** The Licensee has failed to comply with LTCHA, 2007, S.O. c.8, s.3(1)1.

Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity.

### Findings:

1. [REDACTED] this resident asked for assistance to change out of a wet brief. The resident was assisted with the removal of the wet brief but the personal support staff left [REDACTED] without another in its place, also referred to the situation as gross which offended the resident and the resident was left to get [REDACTED] into bed .The resident was cold and humiliated.

**WN #2:** The Licensee has failed to comply with LTCHA, 2007, S.O. c.8, s.6(1)(c).

Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,

(c) clear directions to staff and others who provide direct care to the resident.

### Findings:

1. Plan of care is contradictory re: toileting times. In one place it directs every 2 hours and in another it directs before breakfast, after lunch, before supper, at bedtime and as requested.

**WN #3:** The Licensee has failed to comply with LTCHA, 2007, S.O. c. 8, s. 6(7).

The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan.

**Findings:**

1. The resident did not receive the required care, as [REDACTED] was left with no brief on and no assistance into bed. The plan of care states, "Bladder Continence: Incontinent. Toileting routine. Pads or briefs used. Staff to toilet acb, pcl, acs and hs and as requested. Wears disposable briefs to be checked q2-3 hours and prn, change and provide peri care when needed." (acb= before breakfast, pcl= after lunch, acs= before supper and hs= bedtime)
