Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

- 1. The licensee failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan.[s.6.(7)]
- Resident #004's plan of care directs staff to provide a regular diet with minced textured and pureed when necessary. On November 15, 2012 at 12:15 hours resident #004 was served whole crinkle cut fries. The planned approved minced textured menu for week #4 specifies that whole crinkle cut fries are to be served finely chopped. Resident #004 was not provided a minced textured diet as specified in the plan of care. [s.6.(7)]
- 2. Resident #003's plan of care directs staff to provide this resident with restricted energy minced textured diet. On November 14, 2012 at 12:15 hours resident #003 was served whole green peas and on November 15, 2012 at 12:15 hours resident #003 was served whole crinkle cut fries. The planned approved minced textured menu for week #4 specifies that whole green peas are to minced and crinkle cut fries are to be served finely chopped. Resident #003 was not provided a minced textured diet as specified in the plan of care. [s.6.(7)]
- 3. Resident #002's plan of care directs staff to provide an angled fork and spoon during meals and this resident is not to be served bread buns.
- On November 14, 2012 at 12:15 hours, resident #002 was provided a sub sandwich which contained bread buns and was not provided an angled fork or spoon. On November 14, 2012 at 17:10 hours and November 15, 2012 at 12:15, resident #002 was not provided an angled fork or spoon as specified in the plan of care. [s.6.(7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided as specified in the plan, to be implemented voluntarily.
