The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 15, 16, 17, 21, 22, 23, and 24, 2020.

The following critical incident intakes with log# Log #019288-19 related to prevention of abuse and neglect, and log #015506-19 related to continence care and bowel management, were inspected.

Two non-compliances, one Voluntary Plan of Correction related to LTCHA,2007, c.8, s. 19(1) and a Written Notification 20 (1), identified in this inspection are issued in a concurrent complaint inspection report #2020_526645_0001.

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Care (DOC), Resident Assessment Instrument (RAI) Coordinator, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and Residents.

During the course of the inspection, the inspector performed observations of staff and resident interactions, provision of care, reviewed residents' clinical records, medication administration records (MAR), staff training records and relevant policies and procedures.
