**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s.**

**19. Duty to protect**

**Specifically failed to comply with the following:**

**s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that residents were protected from abuse by anyone.
  - A. A review of clinical records and interviews confirmed that resident #01 was not protected from abuse by resident #03. In 2014, resident #03 touched resident #01 on the groin area. Resident #01 was cognitively impaired and not able to consent to the touch.
  - B. A review of clinical records and interviews confirmed that resident #02 was not protected from abuse by resident #03. In 2014, resident #03 made a sexual gesture and exposed their genitals to resident #02 which was unwanted and upsetting to the resident.

The residents were not protected from abuse. [s. 19. (1)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)  
the licensee is hereby requested to prepare a written plan of correction for  
achieving compliance to ensure that residents are protected from abuse by  
anyone, to be implemented voluntarily.***
