Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

The following intake was completed in this Critical Incident System (CIS) Inspection:

Log #019103-20/ CIS #2201-000009-20 related to an outbreak in the home.

During the course of the inspection, the inspector(s) spoke with the Assistant Administrator, Registered Practical Nurse (RPN), Personal Support Workers (PSWs), and resident.

During the course of the inspection the inspector reviewed residents' health records, staffing schedules, and conducted observations related to the home's care processes.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 17. Communication and response system**Specifically failed to comply with the following:**

- s. 17. (1) Every licensee of a long-term care home shall ensure that the home is equipped with a resident-staff communication and response system that,**
- (a) can be easily seen, accessed and used by residents, staff and visitors at all times; O. Reg. 79/10, s. 17 (1).**
 - (b) is on at all times; O. Reg. 79/10, s. 17 (1).**
 - (c) allows calls to be cancelled only at the point of activation; O. Reg. 79/10, s. 17 (1).**
 - (d) is available at each bed, toilet, bath and shower location used by residents; O. Reg. 79/10, s. 17 (1).**
 - (e) is available in every area accessible by residents; O. Reg. 79/10, s. 17 (1).**
 - (f) clearly indicates when activated where the signal is coming from; and O. Reg. 79/10, s. 17 (1).**
 - (g) in the case of a system that uses sound to alert staff, is properly calibrated so that the level of sound is audible to staff. O. Reg. 79/10, s. 17 (1).**

Findings/Faits saillants :

1. The licensee has failed to ensure a resident being cohorted was equipped with a resident-staff communication and response system at their bedside.

During a tour of the home the inspector observed a resident did not have access to a call bell for use at their bedside. The resident was moved to a different location for cohorting purpose and told the inspector that they did not have access to a call bell. Absence of an accessible call bell at the resident's bedside placed them at risk.

The Assistant Administrator acknowledged that the home failed to ensure that the resident had access to a call bell at their bedside, after they were moved for cohorting.
