Specifically failed to comply with the following:

- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).
- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,
- (a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).
- (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).
- (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).
- (d) contact information for the Director. 2007, c. 8, s. 44. (9).

Findings/Faits saillants:

1. The licensee failed to ensure that the application for admission to the home is accepted unless the home lacks the physical facilities necessary to meet the applicant's care requirements; the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or circumstances exist which are provided for in the regulations as being a ground for withholding approval.

On a specified date a complaint was received, reporting that the long-term-care (LTC) home wrongfully refused him/her admission.

A review of the home's letter of rejection, on a specified date, to resident #001 revealed the ground for refusal of admission as the "nursing home lacks physical facilities necessary to meet the applicant's needs."

A record review of the placement application assessment revealed resident #001 is presently living independently in the community and uses a device for mobility. The resident requested private LTC accommodation. The LTC home was toured by this resident on a specified date and he/she chose this home in which to reside.

An interview with the home's internal placement coordinator, staff #100, identified that the resident's application was rejected because of the size of the ambulatory device in an older home and challenges with safety of movement. He/she stated that while using the ambulatory device resident #001 was able to enter and exit the home, get on and off the smaller of two elevators, was able to mobilize in the hallway, could access the dining facility and washrooms in the home for toileting. Assistance with movement was provided by staff when needed.

An interview with the director of care (DOC) acknowledged that the home had 12 beds for private accommodation and if the resident required assistance with mobilizing, it would be available. The DOC could not establish that the home did not have the physical facilities required by the resident.

The DOC confirmed the resident could be accommodated in the home and the resident's name could have been placed on a waiting list for admission to the home. [s. 44. (7) (a)]

The licensee failed to ensure that if the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out: the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval; and contact information for the Director.
