WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).
(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that any plan, policy, protocol, procedure, strategy or system instituted or otherwise put in place was complied with. The policy named "Medication Administration" effective June 2014 directed staff to "not leave drugs unattended at any time." In August, 2016, a registered practical nurse (RPN) was observed while Their medication cart was outside the dining room. The cart was observed to have a medication cup sitting on top of the cart with a pill inside the cup. The RPN was not able to observe the medication from the dining room, therefore the medication was unattended. This was observed by the Administrator and confirmed by the RPN. The RPN did not follow the home's policy related to medication administration. [s. 8. (1) (b)]
