The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator/Director of Care (DOC), Associate Director of Care, Registered Nurse's (RN's), Registered Practical Nurse's (RPN's), Personal Support Workers (PSW's), and residents.
