Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

Every licensee of a long-term care home shall ensure that each resident of the home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff.

Findings:

On February 21, 2011 it was confirmed by management and the PSW that she had been placing residents at risk by making unsafe transfers by herself when using the resident lift.
