During the course of the inspection, the inspector(s) spoke with the Chief Executive Officer (CEO), Executive Director (ED), Director of Care (DOC), Assistant Director of Care (ADOC), Clinical Care Coordinator (CCC), Restorative Care Coordinator (RCC), Registered Practical Nurses (RPN), Personal Support Workers (PSW), residents and family members.
