The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 29, 2013

This visit was made in response to a critical incident report filed by the home on January 28, 2013 regarding an incident where a magnetically locked stairwell door was released by a resident playing with a fire alarm pull station. The resident entered the stairwell and fell but was not injured.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Environmental Services Supervisor and a maintenance person regarding a fire alarm pull station located on the 2nd floor.

During the course of the inspection, the inspector(s) toured the 2nd floor and tested stairwell doors and tested a newly installed cover and alarm on a pull station and reviewed a service report from Robertson Fire Equipment.
