The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): April 12 to 16, 19 to 23, 26, and 27, 2021

The following logs were inspected during this Critical Incident (CI) System inspection:

log #025545-20 (CI 3025-000038-20) and log #024245-20 (CI 3025-000036-20) related to falls prevention;

log #000194-21 (CI 3025-000001-21) related to incident with injury requiring transfer to hospital;

log #002799-21 (CI 3025-000009-21) related to alleged improper/incompetent treatment of a resident; and

log #006408-21 (CI 3025-000016-21) related to alleged staff to resident abuse.

During the inspection, the inspector(s) observed the provision of care and services to residents, resident environments, resident to resident interactions, staff to resident interactions, dining service, and infection prevention and control practices. The inspector(s) also reviewed resident health care records, investigation notes, and a video.

During the course of the inspection, the inspector(s) spoke with the Managers of Resident Care, the Manager of Infection Prevention and Control (IPAC), the Manager of Property Services/Materials Management/Laundry, IPAC team members, a Personal Support Worker Supervisor, Registered Nurses, a Registered Practical Nurse, and Personal Support Workers.
