The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 4, 5, 9, 10, 2018.

This inspection involved Complaint Log #008985-18 regarding alleged staff to resident emotional abuse, Critical Incident Log #019909-18 (CIR #M609-000042-18) and Complaint Log #022434-18, both regarding an alleged incident of staff to resident financial abuse.

Findings of non-compliance related to this inspection appear on inspection report #2018_770178_0020.

During the course of the inspection, the inspector(s) spoke with a resident, a visitor/friend of a resident, Personal Support Workers (PSWs), Registered Practical Nurses (RPNs), the Program Manager of Hospitality, the Manager of Recreation, Leisure, and Volunteer Services, the Administrator.

During the course of the inspection, the inspector also observed staff/resident interactions, reviewed a resident's medical health record, reviewed home records including the records of investigations of alleged abuse and the home's policy to promote zero tolerance of abuse.
