Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): December 16-18, 2019

This inspection included the follow up of four Compliance Orders: Logs 022169-19 and 022170-19 related to medication administration for an identified resident; and Logs 018249-19 and 022168-19 related to the plan of care for the same identified resident.

During the course of the inspection, the inspector(s) spoke with the Administrator, Program Manager of Personal Care, Quality Improvement Nurse, Registered Nursing Staff, Personal Support Workers, family member and resident.

In addition, the Inspectors reviewed the identified resident health care record along with documents related to the medication management program. Observations were also made of the resident's care environment and the resident's care, including medication administration.
