## **INSPECTION RESULTS**

### WRITTEN NOTIFICATION: Housekeeping

NC #001 Written Notification pursuant to FLTCA, 2021, s. 154 (1) 1.

Non-compliance with: O. Reg. 246/22, s. 93 (2) (b) (iii)

Housekeeping

s. 93 (2) As part of the organized program of housekeeping under clause 19 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,

(b) cleaning and disinfection of the following in accordance with manufacturer's specifications and using, at a minimum, a low level disinfectant in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices:

(iii) contact surfaces;

The licensee has failed to comply with procedures for disinfection of contact surfaces when they failed to ensure the disinfection product was not expired.

According to O. Reg. 246/22, s. 11 (1) (b), the licensee is required to ensure that any plan, policy, protocol, program, procedure, strategy, initiative or system, where the Act or this Regulation requires the licensee of a long-term care home to have, is complied with.

Specifically, staff did not comply with the policy "Environmental Cleaning", revised May 30, 2023.

#### **Rationale and Summary**

The home's policy titled "Environmental Cleaning" stated that expired products including disinfectants where to be discarded when past manufacturer's expiry dates.

During initial tour of the home, it was identified that all AccelINTERVention (1Min) disinfectant wipes throughout the unit were expired, with the expiry date of March 23, 2024. The disinfectant wipes were being used for cleaning contact surfaces. The IPAC Lead confirmed that efficacy of the product could not be guaranteed when expired.
