**During the course of this inspection, the Inspectors observed and tested the resident to staff communication-response system in resident rooms, common areas and outdoor resident areas. The Inspectors tested water temperatures in random areas where residents have access to water, reviewed the licensee's records of water temperatures. The Inspectors observed the condition of the bathing tubs and showers, the walls and floors in the tub room, windows in residents' rooms and in common areas.**
