s. 78. (1) Every licensee of a long-term care home shall ensure that food service workers hired on or after the day this section comes into force, other than cooks to whom section 76 applies, have successfully completed or are enrolled in a Food Service Worker program at a college established under the Ontario Colleges of Applied Arts and Technology Act, 2002 or a Food Service Worker program provided by a registered private career college and approved by the Superintendent of Private Career Colleges under the Private Career Colleges Act, 2005. O. Reg. 249/10, s. 2.

1. The licensee has failed to comply with O.Reg 79/10 s. 78 (1), in that the licensee did not ensure that all food service workers hired after July 1, 2010, have successfully completed or are enrolled in a Food Service Worker program at a college established under the Ontario Colleges of Applied Arts and Technology Act, 2002 or a Food Service Worker program provided by a registered private career college and approved by the Superintendent of Private Career Colleges under the Private Career Colleges Act, 2005.

Staff member #101 was hired on a specified date into a part time position in the home's Laundry department. On a specified date, Staff member #101 began to work occasional food service worker shifts in the dietary department. A review of the dietary department staffing schedule for April 24, 2013 to May 22, 2013 indicates that Staff member #101 has worked several food service worker shifts. The Administrator of the home, reported to Inspector #148 that staff member #101 has been offered a part time food service worker position.

Staff member #102 was hired on a specified date to work as a food service worker in the home's dietary department. A review of the dietary department staffing schedule for April 24, 2013 to May 22, 2013 indicates that Staff member #102 has worked several food service worker shifts.

The Administrator stated that Staff member #101 and #102 have not completed and are not currently enrolled in any Food Service Worker program. Staff members #101 and #102 do not meet the exclusion criteria, set out in O.Reg 79/10, s.76(4).

The Administrator reported to Inspector #148 that both Staff members #101 and #102 are willing to complete the Food Service Worker program and that the home will be working with the staff members to ensure enrollment into an appropriate program. [s. 78. (1)]
