The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 26 - March 2, 2018 and March 5 - 9, 2018.

This inspection was conducted to follow up on:

- An intake regarding compliance order #001, issued during inspection #2017_657681_0015, for Long-Term Care Homes Act (LTCHA) s.20(1) related to the home's policy to promote zero tolerance of abuse and neglect;
- An intake regarding compliance order #002, issued during inspection #2017_657681_0015, for O.Reg 79/10, s.90(2) related to the home's water temperatures; and
- An intake regarding compliance order #001, issued during inspection #2017_657681_0013, for LTCHA s.6(7) related to the plan of care.

Complaint inspection #2018_435621_0006, Other inspection #2018_624196_0006 and Critical Incident System (CIS) inspection #2018_435621_0007 were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Manager of Resident Care, Program Coordinators, Resident-Assessment-Instrument (RAI) Coordinator, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Manager of Food Services, Manager of Physical Services, Manager of Administration, Scheduling Clerk, residents and their families.

The Inspectors also conducted a tour of the resident care areas, reviewed resident care records, home policies, relevant staff training and maintenance records, and observed the delivery of resident care and services, including resident-staff interactions.
