The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): February 26 - March 2, 2018 and March 5 - 9, 2018

This inspection is a follow-up to a Director's Order issued by Karen Simpson as part of a Director Review. The Director Order has been complied with.

This inspection was conducted concurrently with a Follow up inspection #2018_435621_0008, a Complaint inspection #2018_435621_0006, and a Critical Incident System inspection #2018_435621_0007.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Manager of Resident Care (MORC), Program Coordinators (PCs), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Dietary Staff, Housekeeping staff, the Coordinator of Education and Special Services, the Manager of Therapeutic Services, the Manager of Food Services, the Manager of Physical Services, the Laundry and Housekeeping Supervisor, and Scheduling Clerk.

The inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, reviewed numerous licensee policies and procedures, reviewed the abuse and neglect of resident training program and training records, reviewed the homes' implementation of their action plan to address areas of non-compliance identified in the 2017 inspection reports, reviewed the implementation of the new Administrator support plan, and assessed the licensee's progression on the recommendations put forward by Responsive Health Management Inc.

During the course of this inspection, Non-Compliances were not issued.
