Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): March 8-12, and 15-16, 2021.

The following intakes were inspected during this Follow-up inspection:

- One log related to compliance order (CO) #001 that was issued during inspection #2020_853692_0012, regarding s. 20 (1) of the Long-Term Care Home's Act (LTCHA), 2007, specific to developing a process to ensure that staff adhered to the home's policy to promote zero tolerance of abuse and neglect of residents; and,
- One log related CO #002 that was issued during inspection #2020_853692_0012, regarding s. 6 (7) of the LTCHA, 2007, specific to care being provided to residents as per the plan of care.

A Complaint Inspection, #2021_864627_0005, was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Manager of Resident Care (MORC), Resident Care Coordinators (RCCs), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Health Care Aides (HCAs), and residents.

The Inspectors also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed relevant health care records, internal investigation notes, as well as relevant policies and procedures.
