WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44. Authorization for admission to a home

Findings/Faits saillants:

1. The licensee failed to ensure when the licensee withholds approval for admission, the licensee gave to persons described in subsection (10) a written notice setting out, (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; (c) an explanation of how the supporting facts justify the decision to withhold approval.

Under the LTCHA, 2007, s. 44(7) The appropriate placement coordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43(6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless, (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval.

Related to: Log #007709-18:

A complaint was received by the Director indicating a Long-Term Care Home (LTCH) applicant had been refused admission to the home.

Review of the applicant's refusal letter for admission indicated that on a specified date, the applicant was refused admission because the home lacked the physical facilities necessary to meet the applicant's care requirements. The explanation provided by the licensee was related to a specified responsive behaviour that the applicant displayed. The refusal letter was signed by the Administrator of the LTCH.

In a telephone interview with Inspector #571 on May 8, 2018, the Administrator of Pleasant Meadow Manor LTCH, indicated that they initially accepted the applicant for admission to the home. However, the administrator later withdrew the acceptance based on additional information received regarding a specific responsive behaviour. The application for admission to the home was declined as the licensee believed they lacked the physical facilities necessary to meet the applicant's care requirements related to the specified responsive behaviour.

The documented evidence provided by the licensee did not support how the home lacked the physical facilities necessary to meet the applicant's care requirements [s. 44.]
