1. The licensee has failed to ensure making a request in writing to the appropriate placement coordinator for additional information that in the placement co-ordinator's opinion is relevant to the licensee's determination of whether to give or withhold approval for the applicant's admission to the home.

On a day in 2021, the licensee sent a letter to Champlain Home and Community Care Support Services (HCCSS) and to the applicant's substitute decision maker (SDM) indicating that the application for admission at Residence Prescott-Russell Long-Term Care had been refused. The letter indicated that the staff of the home lacked the nursing expertise necessary to meet the applicant's care requirement related to the resident's responsive behaviors.

The DOC stated that the resident's application for admission to the home was refused because of the following reasons:

There were discrepancies between the information related to the applicant's medical diagnosis, the allergies and the applicant's responsive behaviors to determine whether to give or withhold approval for the applicant's admission to the home, received from:

- the Health Assessment Long-Term Care Homes Act, 2007,
- Champlain HCCSS Behavioral Assessment Tool, and
- the InterRAI Home Care (HC) Assessment forms.

The DOC validated that further additional information was not requested in writing to the appropriate placement co-ordinator to clarify these above discrepancies.

As such, the applicant's admission approval to the home was withdrawn by the licensee without requesting additional information in writing to the appropriate placement coordinator to clarify discrepancy of information related to the resident's health care records.
