WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 225. Posting of information Specifically failed to comply with the following subsections:

- s. 225. (1) For the purposes of clause 79 (3) (q) of the Act, every licensee of a long-term care home shall ensure that the information required to be posted in the home and communicated to residents under section 79 of the Act includes the following:
- 1. The fundamental principle set out in section 1 of the Act.
- 2. The home's licence or approval, including any conditions or amendments, other than conditions that are imposed under the regulations or the conditions under subsection 101 (3) of the Act.
- 3. The most recent audited report provided for in clause 243 (1) (a).
- 4. The Ministry's toll-free telephone number for making complaints about homes and its hours of service.
- 5. Together with the explanation required under clause 79 (3) (d) of the Act, the name and contact information of the Director to whom a mandatory report shall be made under section 24 of the Act. O. Reg. 79/10, s. 225 (1).

Findings/Faits saillants:

1. The licensee failed to ensure that the most recent audited report was posted.

During the initial walk through of the home the inspector and a member of management observed the reconciliation report for the year ending 2009 was posted. The 2010 reconciliation report was available within the home but not posted.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 241. Trust accounts Specifically failed to comply with the following subsections:

- s. 241. (10) The licensee shall have every trust account established under subsection (1) audited annually, (a) by a public accountant licensed under the Public Accounting Act, 2004; or
- (b) in the case of a municipal home or a joint home approved under Part VIII of the Act, by the municipal auditor who audits the books of account and ledgers of the home. O. Reg. 79/10, s. 241 (10).

1. The licensee failed to ensure that all trust accounts have been audited annually by a public accountant licensed under the Public Accounting Act.

A member of management in the home confirmed to the inspector that the trust accounts have not been audited on an annual basis. The home indicated they were in a catch up situation. The last trust account audit completed was for the year ending 2009. The 2010 trust account audit has not yet been finalized.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all trust accounts have been audited annually by a public accountant licensed under the Public Accounting Act. This plan is, to be implemented voluntarily.
