Findings/Faits saillants :

1. The licensee has failed to ensure that the plan of care for toileting for resident # 2 sets out clear directions to staff and others who provide direct care to the resident.

Review of the plan of care for toileting for resident # 2 reveals that the resident requires one person extensive physical assist for toileting.

Staff interviews reveal that a commode is normally placed at the resident's bedside for the resident to use independently at night. However the resident's written plan of care does not instruct staff that the resident uses a commode. [s. 6. (1) (c)]
